

INCOURAGE MARTIAL ARTS FREE TRIAL MEMBER AGREEMENT

1. This agreement is executed between InCourage Martial Arts and the Buyer/Guardian, who has agree to have his/her signature to be affixed hereto electronically -- by checking the "I have read and agree to InCourage Martial Arts' free trial agreement" box.
2. InCourage Martial Arts agrees to provide Martial Arts instruction to the Student during scheduled instruction hours and for the trial period starting on the "Trial Start Date".

Evening Classes: 14 days free trial program
After School Care: 14 days free trial program
Cost: \$0

3. There is no obligation for the Buyer/Guardian to continue with the program after the trial period.

MEMBER HEALTH & SAFETY

1. Safety is the number one priority at InCourage Martial Arts, yet it is not the sole responsibility of our's instructors and staff. Students have the right and responsibility to train and conduct themselves in a manner that is safe and should be mindful of the safety of themselves and those around them. Buyer/Guardian agrees to immediately raise any and all safety concerns -- including, for example, members performing skills incorrectly, a member acting with reckless disregard for the safety of others or an equipment defect -- with the instructors and staff at InCourage Martial Arts and, if they believe such person has not address the concern, with an upper management contact supplied by the staff.
2. Buyer/Guardian agrees that all exercises and/or courses are undertaken at each members own risk. Buyer/Guardian and Student(s) understand the procedures and exercises involved in instruction and participation as explained to him/her by a representative of InCourageMartial Arts. Buyer/Guardian understand that there is a risk of personal injury involved in the course of instruction and with this knowledge agrees to indemnify and save harmless InCourage Martial Arts its representatives, agents and employees from all losses caused by accident or injury to the Student(s), or to third

persons in the event that either the Student(s) or such third person is injured in any way during the performance and execution of exercises.

5. Buyer/Guardian certifies that the Student is in good health and have no physical limitations that would or should prevent the Student from participating in Martial Arts exercises or other physical activity. InCourage Martial Arts recommends for each Student to visit a physician and undergo a physical prior to enrollment to ensure good health. If the Buyer/Guardian is not confident in the Student overall health then he or she should consult with a physician before the Student engages in new physical activity.

6. As the Buyer/Guardian, and in the event I can not be reached in an emergency, I hereby give permission to the InCourage Martial Arts staff to administer all necessary first aid, and to engage a physician to administer treatment, including hospitalization, to the Student. Buyer/Guardian certifies that the Student is covered by health insurance.

ADDITIONAL TERMS

1. Buyer/Guardian irrevocably authorizes InCourage Martial Arts, its successors and assigns, and those acting under its authority, to copy, use or publish for art, advertising, trade, or any other lawful purpose whatsoever, photographic portraits, pictures or videotapes of the Student, in which he, she or they may be included in whole or in part.

8. I am not under their influence of any drugs, alcohol, or other intoxicants. I am not suffering from any illness or incapacity.

9. I acknowledge I have read (or have had read to me) the terms of this agreement in its entirety. If am designated as the Buyer/Guardian, I am the parent or legal guardian or adult responsible for the Student, with full authority to act on his/her behalf.
